Open call for short-term *visiting lecturer* in **Bioethics and Biolaw and PHD of Law**, at the University of Milano-Bicocca, in Milan, Italy. The call is part of Erasmus Plus Project (KA107) at Milano-Bicocca University, in Milan, Italy. The teaching is at the Department of Law, part of the Erasmus+ Jean Monnet Module *Emerging 'moral' technologies and the ethical-legal challenges of new subjectivities*, co-financed by the European Union (www.motecls-jeanmonet.unimib.it). The courses range from analytical legal philosophy (analysis of legal concepts, analysis of legal language, discrimination) to bioethical and biolegal issues (genetics, end-of life, experimentation with humans, data protection, human enhancement, robotic and AI).

Assessment criteria include:

• the applicant's previous teaching experience on the topic of proposed courses

- research and publications on the topic of the proposed courses
- supervision of academic papers of students and PHD students on the topic of the proposed courses
- knowledge of the bioethical context of the hosting country
- the applicant's availability to travel during the period indicated by the call
- ability to teach both in English and Italian
- Language skills: in English B2 and in Italian B1*

The teaching consists of **8 hours** of frontal lessons and will be held in Italian and English. The exact duration of the visit is negotiable. Travel and Individual support will be entirely covered by the project, based on the grant conditions as stated in the Inter-institutional agreement signed.
