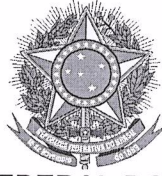

The Evaluation Committee has proceeded with the evaluation of curriculum and qualifications (up to 80 points) and Language Proficiency (up to 20 points).

The following assessment criteria has also been taken in account:

- the applicant's previous teaching experience on the topic of proposed courses
- research and publications on the topic of the proposed courses
- supervision of academic papers of students and PHD students on the topic of the proposed courses
- knowledge of the bioethical context of the hosting country

- Language skills: in English B2 and in Italian B1
